Recruitment for the Post of Ayurvedic Commissioner in North Western Provincial Council Public Service

Applications are invited from officers currently serving in the Public and Provincial Public Service in the Ayurvedic Medical Service Administrative Grade I, Ayurvedic Medical Service Administrative Grade II, and Ayurvedic Medical Service Medical Officer Grades I and II, for appointment to the post of Ayurvedic Commissioner in the North Western Provincial Public Service, in accordance with the recommendation of the Chief Secretary and the approval of the Honourable Governor of the North Western Province.

Note:

- Applicants with I.1(b), I.1(c), I.1(d), and I.1(e) qualifications will be considered, respectively, if the officers with I.1(a) qualifications have not applied.
- Only a group of eligible officers of the same grade will be called for the relevant interview at one time, and only the officers who are in the relevant grade on the date of fulfilling the qualifications will be considered.

01. 1 Qualifications:-

(a) Being an Officer in the Ayurvedic Medical Service - Administrative Grade I

or

(b) Should have completed three (03) years of active and satisfactory service in the Ayurvedic Medical Service - Administrative Grade II and should have earned three (03) salary increments.

or

(c) Being an officer who has served for less than three (03) years in the Ayurvedic Medical Service- Administrative Grade II

or

(d) Being an Ayurvedic Medical Service- Medical Officer Grade I

or

(e) Should have completed eight (08) years of active and satisfactory service in the Ayurvedic Medical Service - Medical Officer Grade II and have earned eight (08) salary increments within the prescribed period.

(In addition to the qualifications mentioned in 1.1 (b), 1.1 (c), 1.1 (d), or 1.1 (e) above, the following qualification i and ii must also be fulfilled.)

- i. Should have obtained Post Graduate degree in Ayurvedic Hospital Management which is not less than two years from a local or foreign higher education institution, post-graduate study institution or university recognized by the University Grants Commission.

and

- ii. Should have completed not less than 03 years of service as the Officer in Charge /Medical Superintendent in a Research/Teaching Ayurvedic Hospital, District Ayurvedic Hospital/Rural Ayurvedic Hospital approved by the Department of Management. (a formal appointment or acting appointment to a post belonging to Administrative Grade II or Grade I of the Ayurvedic Medical Service will also be taken into consideration when evaluating the period of service).

1.2. Not being subject to any disciplinary punishment in accordance with the provisions of the Public Service Commission.

1.3. All the qualifications for the post should have been completed by 20.08.2025.

Note: All the above qualifications must be fulfilled as at the closing date of applications, and self-attested photocopies of all certificates confirming the above qualifications, as well as a self-attested photocopy of the National Identity Card, must be attached to the application.

02. Method of Selection:

Selection will be made on the merit order of marks obtained in a structured interview conducted by an interview panel nominated by the Secretary to the Governor of North Western Province with the approval of the Honorable Governor of North Western Province.



Duly and accurately filled applications should be sent through the Head of the Department and the Secretary to the Ministry concerned (In case of an officer absorbed in the Provincial Council, the application should be forwarded with the recommendations of the Secretary to the Provincial Ministry and the Chief Secretary.) under registered post to reach “**Secretary to the Governor, Governor’s Office, Maligawa, Kurunegala**” on or before 20.08.2025. “**Inviting Applications to the Post of Provincial Ayurvedic Commissioner -North Western Province**” should be written in the top left hand corner of the envelop enclosing the application. The applications which are late, incomplete or sent by the applicants who do not complete the required qualifications by the closing date will be rejected without prior notice. Governor’s Office – North Western Province will not entertain any complaint against late or losses of applications.

Any matter not provided for in this notification regarding this recruitment shall be determined by the Governor of North Western Province.

If there is any inconsistency among the language phrases of this notification which is published in Sinhala, Tamil or English, the Sinhala text shall prevail.

The decision of the Governor - North Western Province will be final and conclusive on the recruitment for this post.
